DR. BEN MCNEILL

Dr. Ben McNeill was the first of seven children born to John and Sally Ann McLean McNeill. John McNeill, according to a family tradition, disappeared at or near the close of the Civil War supposedly bushwhacked by Yankees on his return trip home. Following their father's death, the McNeill children were supported by their mother's brother, Hector McLean.

Dr. Ben McNeill and his younger brother, Dr. John McNeill were educated at Edinburgh Medical School in Raeford, NC. This school was incorporated by the legislature as the state's official medical school and offered a one year course of study. The McNeill brothers graduated in 1871-72. Following studies at Raeford, both John and Ben attended Hope Mills Medical School in Charleston, SC and Belville Medical School in New York.

In 1886, the McNeill brothers arrived in Shallotte and began a practice. At this time, they were the only doctors in that immediate area. As was commonplace for all doctors in rural areas, the McNeill's often times were paid with chickens, corn, and other farm products and often times not paid at all. The McNeill's were typical old country doctors traveling long distances over poor roads and through inclement weather.

Dr. Ben McNeill, the subject of this newsletter stayed with the Samuel W. Maultsby family in the Supply area after his arrival in the county in 1886. The Maultsby family lived just north of the present day campus of Brunswick Community College.

McNeill kept an account ledger of his patients during the years 1887-1889 while staying with the Maultsbys. The ledger includes 398 entries with those individuals scattered throughout the county and into Columbus and Horry Counties. Of those 398 patients, a large portion did pay with farm products, but if one takes the amount all patients were billed for, the sum total is \$4,991.61 for the three year period. The average visitation fee was \$12.54.

Accounts were settled with all sorts of farm products including fodder, corn, corn shucks, peas, pea tops, forage, peanuts, rice, chickens, turkeys, and cows. Patients near the coast would often times pay with oysters and clams. Others would pay with their own labor for Dr. McNeill-hauling shingles or hunting cows.

Dr. Ben McNeill was highly regarded by the citizens in the communities that he served not only as a doctor but as a gentlemen. Tales of his kindness and generosity may still be heard from a few of our older residents. An excellent example involves the Francis Payton and Celia Katherine Elvington McKeithan family of Bolivia in the year 1887 when Dr. McNeill was called to deliver a baby to Mrs. McKeithan. The child was named McNeill McKeithan in honor of Dr. Ben McNeill.

As Dr. McNeill continued in his practice his name and reputation spread. He was elected to the state legislature in 1900 to represent the people of Brunswick County. While serving in that capacity, he had a heart attack on the floor of the legislature and died shortly thereafter afterwards. He was buried in Maxton, NC.

Following the death of his brother, Dr. John McNeill moved to Whiteville in 1901. He loaded the effects of his medical practice on mule and cart and headed towards Whiteville. When he came to the Waccamaw River, it was at flood stage and could not be crossed, forcing Dr. McNeill to return to Shallotte. There, the effects were loaded on a schooner lying in the Shallotte River to be shipped to Wilmington and from there to Whiteville by rail. However, the schooner was destroyed in a storm off Lockwood Folly Inlet marking the first and only time that a medical practice was "lost at sea."

Dr. John McNeill did make it to Whiteville and there he began a prosperous Drug Company that still bears the McNeill family name.



Mr. Thomas Robbins claims that his account was only 16 dollars and he settled that in your office at Shallotte but got medicine to the amount of 2 dollars for which he paid 1.50 leaving a balance of 50 cents.

Mr. Outlaw claims that your account was 3 dollars and he paid you one dollar at the time.

Fortune (no last name listed) will put 2 bushels peanuts to J. W. Vereen Dec. 21, 1889.

Peter Vaught claims that he lost more from clams bought of you than his account.

James Morse wants you to send an itemized bill.

Dexter Bellamy will apy by March 1, 1890.

McDaniel Bennett will send the amount due by mail within 3 weeks from the 16 December.

James Slade claims a credit of 223 pounds fodder 2.23 dollars.

William Bland wants you to send and get a cow and calf at 20 dollars and potatoes at 50 cents.

William Bland will pay 2.77 dollars for James Slade on the first Monday in January 1890.

Ben Hewett claims that he paid you 2 dollars at one time and 2 1/2 at another time for whcih he has no credit.

J. D. (or S.) Stanley claims that you are due him for feeding cattle \$36. 260 pounds fodder 2.60. 3 bushel (no description) 3.00. Cash 2.00. Total 43.60.
